

MANDATE

HI's activities in Cambodia currently cover a wide range of activities aiming at reducing preventable impairments, improving access to quality health and rehabilitation services and promoting socio economic empowerment.

SITUATION

Cambodia reached, after several decades of isolation and conflict, an end to armed conflict in 1998 following the full integration of Khmer Rouge into the national army. Cambodian people have since enjoyed relative stability, which has allowed economic growth and some significant progress, including a decline in the maternal and infant mortality rate, for which HIV/AIDS, malaria and landmine/unexploded ordnance accidents were responsible. Nevertheless, it is estimated that a quarter of the population lives below the poverty line. Another serious problem is road safety: there has been a 10% increase in road accident mortality since 2005. About 4% of Cambodia's population is disabled, mostly because of landmine or unexploded ordnance and road accidents, or as a consequence of birth or illness. People with disabilities, particularly children, suffer from a wide range of problems and form one of the most vulnerable groups in Cambodian society. However, as the government financial resources remain scarce assisting people with disabilities is not always perceived as a priority. The lack of a well-functioning and well-funded public health care system means that international organizations remain primarily responsible for the disability & rehabilitation sectors.

BACKGROUND

HI was born in the Cambodian refugee camps in Thailand in 1982. The organization has been operational in the Cambodian territory and started with the organization of campaigns against landmines and the management of physical rehabilitation centres welcoming landmine survivors as well as other people with disabilities. HI's currently implement activities, which are answering to the wide-range scope of needs of Cambodian people with disabilities.

Mother and child health

OBJECTIVE

Improve access and quality of preventive and therapeutic care for children (0-6 years) with disability or at high risk through the strengthening of community-level health systems and local partners.

METHOD

- · Detection of/and service provision to children with disabilities via "mother and child health" program field activities
- Integration of general knowledge on child development, disability, causes and prevention into stakeholders' (government and NGOs) strategies
- Development of nationally recognized screening tools for newborns, infants and young children
- · Integration of screening tools into health system via ministry of Health, National maternal child health center
- Collaboration with universities
- · Development of a national model for a participatory approach to inclusive healthcare

Road Safety

OBJECTIVE

The general objective is to increase awareness about road safety by assessing the status of road safety in Cambodia, and to evaluate the interventions implemented as part of the RS-10 initiative¹. Furthermore, the programme plans to build the capacity of 100 factory workers to become focal points on road safety concepts to in turn sustainably enable them to transfer road safety knowledge to other factory workers.

METHOD

- Develop a training of trainer guideline for factory workers
- Research, monitoring and evaluation of quantitative data in order to provide accurate information on the most relevant issues for the purpose of developing action plans in road safety intervention.

Livelihood Projects

OBJECTIVE

The objective of the project is to contribute to sustainable reduction in poverty and social exclusion and to improve quality of life among people with disabilities and other disadvantage households.

METHOD

HI promotes access to livelihood for people with disabilities in various ways:

- The association defines realistic (i.e. market adapted) personalized professional projects for disadvantage members within target vulnerable household, among which persons with disabilities. Once defined, a personalized vocational training is organized and a starting kit is provided in order to enable the persons to start their business. Alternatively, young persons are supported to access wage employment opportunities,
- Support to existing service providers to remove barriers preventing people with disabilities and other disadvantaged groups to access livelihood, health, training and other services,
- Support to local authorities, people with disabilities and other disadvantaged groups at commune level to advocate for their needs and set up an appropriate response using the mechanism in place for local development.
