



Haiti



MANDATE

Present in Haiti even before the earthquake of January 2010, Handicap International launched an immediate response on a scale unprecedented in the organisation's history in aid of people affected by the disaster. Handicap International's emergency humanitarian relief effort lasted almost two years. Its efforts now focus on development activities to help the country build the services necessary to answer the needs of vulnerable people and people with disabilities and ensure their full inclusion in Haitian society.

SITUATION

One of the poorest countries in the world, Haiti is regularly affected by natural disasters and has suffered from chronic political instability. Needs vary enormously from region to region and population to population. People living in the capital Port-au-Prince have acute needs, resulting from high employment, especially among young people, the rising cost of basic foods, insecurity, and poor access to water and education. In rural areas, the lack of services (schools, health centres, etc.) is blatant and the population is even more vulnerable when faced to natural disasters (cyclones, floods, droughts...). Set against this background of widespread poverty, the situation facing people with disabilities is even more alarming and their basic needs are often not met (water, food, accommodation, care, access to orthopaedic-fitting and security).

INITIAL ACTIONS

Handicap International launched its first operations in Haiti in partnership with the World Food Programme (WFP) in 2008, when it managed a logistics platform to supply humanitarian aid to areas that had become difficult to access following severe flooding in the region of Gonaïves (two hours to the north of Port-au-Prince).

Risk and disaster management

GOAL

Reduce the vulnerability and build the capacities of the most vulnerable individuals, in particular people with disabilities, older people, people with chronic diseases and/or isolated people, women and children, to better prepare them for natural disasters (risk reduction) and to enforce their rights in crisis situations (emergencies) caused by natural disasters.

METHOD

The method used for this project combines several complementary approaches:

- An **inclusive approach** based on the use of tools and practices to promote the active involvement of people with disabilities and to ensure their specific needs are taken into account
- A **capacity-building approach** targeted at operators at every level (national, departmental, communal, communal section and locality)
- A multi-hazard approach targeting all major hazards identified in Haiti and targeted localities (cyclone, flooding, landslide, tsunami, earthquake)
- A **participative approach** to increase awareness of local risks, foster community involvement in the process, particularly the most vulnerable individuals, and improve the ownership/sustainability of risk reduction actions implemented by communities.

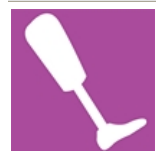

Rehabilitation

GOAL

- Providing disabled people who need rehabilitation care with quality, accessible and sustainable rehabilitation services within the Haitian health system.
- Helping the Ministry of Health and Population develop an inclusive public health policy.

METHOD

Handicap International builds the capacities of rehabilitation technicians with minimal or informal training to upgrade their skills, and provides ongoing training for rehabilitation professionals.

Handicap International provides sustainable support (structural and technical) to develop and build the capacities of pre-existing facilities and the quality of sustainable rehabilitation services in six departmental hospitals and five rehabilitation facilities. Handicap International also ensures training programmes in three nursing colleges provide basic knowledge of disability and rehabilitation concepts.

Child protection

GOAL

Help strengthen the child protection system in Haiti.

METHOD

Handicap International provides support to the Ministry for Social Affairs and Work to enhance its child protection policy mechanisms and improve the quality of care provided to abandoned children in host families and children's homes. Handicap International also works in the sexual and reproductive health sector where it is running a pilot project to improve the living conditions of vulnerable orphan children in two special schools and a children's home.

Inclusive employment

GOAL

Enhance the professional inclusion of people with disabilities in the Port-au-Prince metropolitan area.

METHOD

Handicap International works in conjunction with a local partner (Sant Kore Lavi) to help people with disabilities develop and implement their personalised business projects. To ensure more people with disabilities are able to access inclusive employment, the project works with three economic development actors (an occupational training centre, a social micro-finance institution and a public market) with a view to helping them make their services more inclusive and accessible, particularly for people with disabilities. Awareness-raising campaigns are also organised in communities where people with disabilities live in order to build their capacities and potential to exercise an occupation. At national level, the project also aims at raising the awareness of economic actors in order to better include people with disabilities in their services.

Road safety

GOAL

Improve road safety for road users.

METHOD

The methodology used for this project includes several complementary approaches:

- **A multi-sector capacity-building approach** for institutional and civil society operators involved in the management, implementation and coordination of road safety actions, while fostering the development of an appropriate institutional framework.
- **An awareness-raising approach** which aims at improving awareness of road hazards and the adoption of safer behaviour by road users.
- **An accessibility approach** which aims at promoting access to public transport for people with disabilities and people with reduced mobility.

 - Pedestrians living in the area, students and teachers at schools in the area, tradespeople (shops and stalls), people with disabilities
 - Drivers of private cars, goods and passenger transport vehicles, and their passengers
